This letter shall serve as notification that the Statewide School Readiness Contract ("SR Contract") and Statewide Voluntary Prekindergarten Provider Contract ("VPK Contract") between the Early Learning Coalition of Indian River, Martin & Okeechobee Counties and TLC Preschool of Sebastian Inc. ("TLC") was terminated for cause effective November 27, 2018. Termination of the SR Contract and the VPK Contract is pursuant to the following contract sections:

- Termination for Cause as set forth in the SR Contract, paragraph 57(a) Action, or lack of action, which threatens the health, safety or welfare of children and 57(b) The material failure to comply with one or more of the terms of this Contract.
- Termination for Cause as set forth in the VPK Contract, paragraph 54(a) Action, or lack of action, which threatens the health, safety or welfare of children and 54(b) The material failure to comply with one or more of the terms of this Contract.

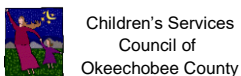
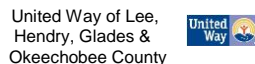
At the request of the TLC Preschool, a Review Committee Hearing was convened on November 30, 2018, at 9:00 a.m. The following claims were discussed and voted on by the committee:

- Termination of the current VPK and SR Contracts – Committee voted to uphold the termination of the current contract effective November 27, 2018.
- Revocation of the VPK and SR Contracts for 5 years – Committee voted not to uphold the revocation.
- The contract eligibility status for TLC will be reviewed by staff prior to July 1, 2019, for determination of eligibility.
