CLASS GROUP COACHING- \$1200

ELIGIBILITY REQUIREMENTS

- ALL Early Learning Directors and Teachers are eligible to participate.
- Participants who received a stipend for CLASS Group Coaching during the 22/23 fiscal year may not take the same CLASS Group Coaching and receive a stipend in the 23/24 fiscal year (unless the age level in which they teach has changed.)
- Teachers may only apply for the age level that they teach in.
- If a participant started but did not complete all CLASS Group Coaching sessions in 22/23, all 12 sessions must be taken/re-taken and completed between July 1, 2023 and June 30, 2024 to receive a stipend.
- ALL 12 sessions must be completed to be eligible for the bonus.
- All requirements must be completed between July 1, 2023, and June 30, 2024. Requirements completed prior to July 1, 2023, will not be considered.
- School District directors/teachers may participate, but do not qualify for stipend.
- Submit the completed eligibility application before enrolling in courses and provide all required documents and proof of completion.
- Directors are not required to participate in CGC sessions with staff. However, they are highly encouraged to take any age level they have not yet completed.

PERFORMANCE BONUS FOR TEACHERS - \$500



Requirements

Teacher must participate in professional development offered through ARPA initiatives or ELCIRMO Early Childhood Specialists AND Instructional Support domain score must increase by 0.50 or more. If teacher does not have a previous score, the minimum Instructional Support domain score must be 3.00 or higher.

CLASS OBSERVER CONTINUED

ELIGIBILITY REQUIREMENTS for the CLASS Observer Director and Teacher Training Bonus:

- **Contracted** SR and/or VPK directors and teachers are eligible to participate.
- Directors may complete all levels. Stipends will be paid out for up to 2 levels.
- Teachers may complete the course for the age level they teach.
- **Not eligible to retake if the Director received a stipend in the 22/23 fiscal year. Directors that completed one or two CLASS Observer courses in 22/23, may complete the remaining level(s) in 23/24 and receive a stipend.**

CONTINUOUS QUALITY IMPROVEMENT PLAN - CQI

Requirements – up to \$19,800

Continuous Quality Improvement Application submitted to ELCIRMO by Provider

Program must provide a minimum of 24 hours of training time including live coaching, live instruction, virtual instruction, individual and group instruction, and other competency-based skill development exercises

The director must participate in the training along with 75% of educational staff

Funds can be used to cover any program costs, including compensating employees for their training time

IMPORTANT: Must work directly with an Early Childhood Specialist/Quality Specialist from ELCIRMO to develop and implement your plan **IF** you are approved.

CONTINUOUS QUALITY IMPROVEMENT PLAN - CQI

ELIGIBILITY REQUIREMENTS for the Continuous Quality Improvement Grant:

- **Contracted** SR and/or VPK providers may apply for a grant of up to \$19,800 to develop/implement a program to strengthen practices that support effective interactions, strengthen business and leadership practices, support child assessment and screening with reliability, or other local priorities.
- **Providers may not use previous CQI Grant Application from 22/23 Fiscal Year.**
- **At least 75% of education staff must participate in the 24 hours of training. (i.e. teachers, directors, coaches, substitutes, etc.).**
- All requirements must be completed between July 1, 2023, and June 30, 2024. Requirements completed prior to July 1, 2023 will not be considered.
- Submit required, documented proof that requirements were met with CQI Completion Form.

School District and Head Start Early Learning Educators are not eligible to receive stipends/grants.

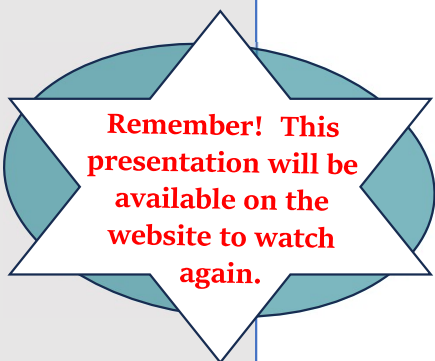
