Requirements

Provider application submitted to ELCIRMO

Submit Required Documents to ELCIRMO

Attention!

This can be used for expenses such as:

- Supplies and/or classroom material costs
- Operating costs
- Rent/Utilities
- Payroll, salaries, and/or stipends

The grant can cover any expenses dating back to July 1, 2023 through June 30, 2024.

Document Submission:

- Any documentation and/or receipts will need to be submitted onto REVVER no later than June 30, 2024.

WHO CAN APPLY?

Contracted and Non-Contracted Providers who were operational as of July 1, 2023.

DEADLINE

All requirements met by June 30, 2024

**Funding will be determined based upon licensing capacity.

APPLICATION REVIEW

2023- 2024 ARPA Stabilization and Classroom Materials Grant

Funding received from the **2023 - 2024 ARPA Stabilization and Classroom Materials Grant** can be used for the following expenses occurred between July 1, 2023 - June 30, 2024:

- Supplies and/or classroom material costs
- Operating costs
- Rent/Utilities
- Payroll, salaries, and/or stipends

**All receipts must be submitted to ELCIRMO (via REVVER) by June 30, 2024.*

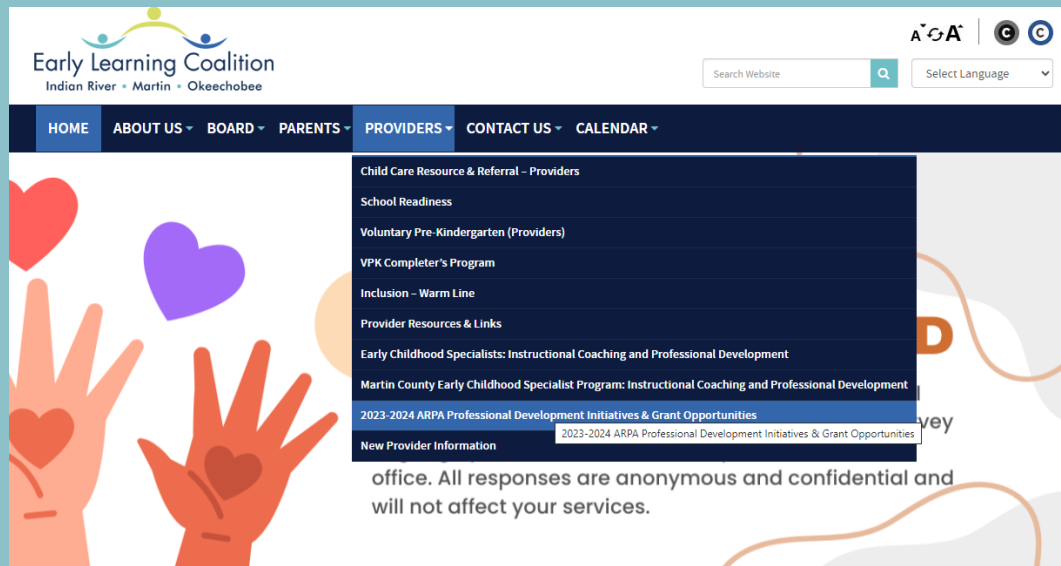
