- Participants who received a stipend for CLASS Group Coaching during the 22/23 fiscal year may not take the same CLASS Group Coaching age level and receive a stipend in the 23/24 fiscal year.
  - $\circ$   $\;$  Teachers may only apply for the age level they teach.
- If a participant started but did not complete all the CLASS Group Coaching sessions in the 22/23 fiscal year, all 12 sessions must be taken/re-taken and completed between July 1, 2023 and June 30, 2024.

#### **ELIGIBILITY REQUIREMENTS for the Continuous Quality Improvement Grant:**

- Contracted SR and/or VPK providers may apply for a grant of up to \$19,800 to develop/implement a program to strengthen practices that support effective interactions, strengthen business and leadership practices, support child assessment and screening with reliability, or other local priorities.
- Providers may not use previous CQI Grant Application from 22/23 Fiscal Year.
- At least 75% of educational staff must participate in the 24-hour training. (i.e., teachers, directors, coaches, floaters, etc.).
- All requirements must be completed between July 1, 2023 and June 30, 2024. Requirements completed prior to July 1, 2023 will not be considered.
- All requirements completed by June 30, 2024.
