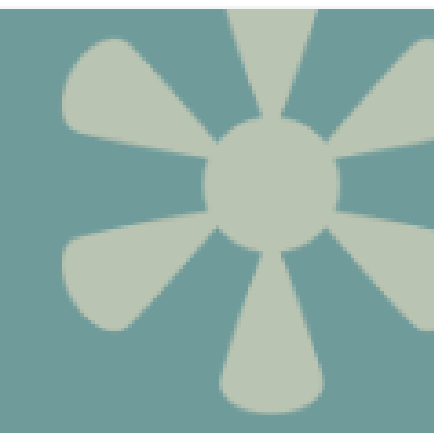

Staff Training Day

As required by Rule 6M-4.500, effective 5/13/25, SR contracted providers will be reimbursed for up to 13 holidays. If the provider chooses to have the optional 13th holiday, it must be a Coalition-approved staff training day. At least 75% of staff must be in attendance. The training length must be equal to or more than 50% of the center's operational hours (open 10 hours, training must be 5 hours). The training day may be a combination of various presenters.

ELCIRMO will be offering (2) in-person staff training days as a Professional Development option. The conference will be 1/16/26 and 2/13/26 at IRSC Massey Fort Pierce Campus. The conference will be 6 hours, including a break for lunch. There will be breakout sessions appropriate for all staff. More details to come.

A provider may select their own Professional Development training to for ELCIRMO for approval. Approved staff trainings are listed on page two. A provider may select a training that is not listed, subject to approval from the Coalition.

Certificates of Completion and attendance documentation will be required for every staff member.

SR_VPK Attendance & Uniform Policy Processes

- ✚ Attendance must be submitted no later than the third business day of the month.

Enrollment/Attendance submitted before or after the due date will be considered late and will not be processed in the next payment cycle.

REVER

Deadline: 3rd business day of each month by 5:00 PM:

- ✚ Sign-In Sheets: Must be submitted in alphabetical order, matching the portal records. This will help us process attendance records faster and efficiently
- ✚ All required documents must be uploaded to the designated folder to be able to review your monthly attendance roster.
- ✚ **Importance of Ending Enrollments in the Provider Portal:**
- ✚ This will help us Availability of open slots so that children on the waiting list can be enrolled promptly, depending on funding.
- ✚ **Rilya Wilson Act:** Applies to children in out-of-home care or under child protective services. (All BG1) Reminder: Daily Attendance Tracking call LOG.is required.
- ✚ We encourage you to please read or email. We sent a lot of good information that can help you streamline the process.

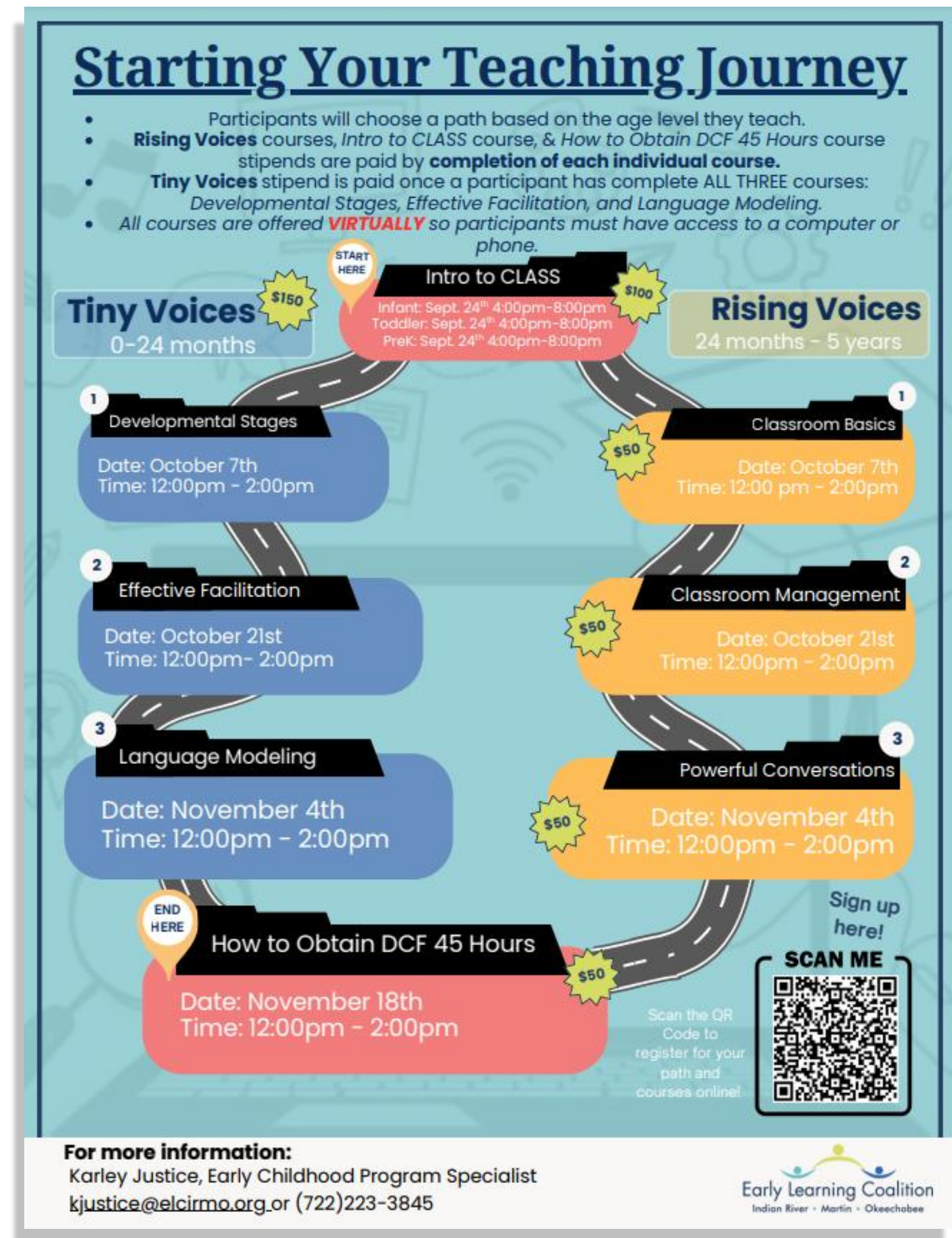


