This **one-time stipend** is for child care providers in Indian River, Martin or Okeechobee counties with an active **School Readiness Contract**, who have met all of the following criteria:

Stipend Criteria and Requirements:

- The Provider has an active School Readiness (SR) contract with ELCIRMO, which has been in good standing continuously from 7/1/18 through the date of stipend payment disbursement date, estimated to be the week of 5/27/19;
- The Stipend is for child care Providers whose child care facility is in Indian River, Martin or Okeechobee counties;
- The Stipend will be based on April 2019 attendance of contracted SR children ages birth to three years old (up to 36-months of age);
- Provider agrees to use Provider Stipend for **quality improvement*** efforts for Infant/Toddlers at the child care facility listed in this application;
- Provider agrees to **FULLY EXPEND Stipend funds and receive all materials by June 28, 2019.**
- Provider agrees to maintain receipts and/or records as evidence of how funds were spent, and to provide records, if requested, in accordance with the records retention clause in the School Readiness contract;
- The Provider Stipend initiative is awarded if School Readiness funds are available.
